With respect to standalone financial results, the figures for the quarter ended 31 March 2018 and 31 March 2017 represents the difference between the audited figures in respect of full financial years and the published figures for the nine months ended 31 December 2017 and 31 December ' 2016 respectively. With respect to consolidated financial results, the Company has not published the quarterly results in the current year using the exemption available under Securities And Exchange Board Of India (Listing Obligations And Disclosure Requirements) Regulations, 2015. Accordingly for the consolidated financial results, the Company has presented only the results of current year and previous year,
3. An investment of Rs 790 Lacs has been made by the Company in a subsidiary named M/s. Accel IT Resources Limited (AITRL.) and advanced loan (including interest) amounting to Rs. 622 Lacs. The net worth of AITRL. is negative as at 31st March 2018. The management of the subsidiary has been revamped to restructure operations to optimize revenue generation by investing in technology and adding customer base. A new business plan has been put in place and the subsidiary has got the training centers accredited to National Skill Development Corporation (NSDC). The management of the subsidiary and the company is of the view that these business plans will help the company grow business and improve the financial position of the subsidiary thereby enabling the recovery of these investments and loans given alongwith interest, in the standalone financial results. Consequently the Company Management is of the view that goodwill amounting to Rs. 414 Lacs recognized relating to this investment will be recovered and hence no provision needs to be made for the same. This is a subject matter of qualification in the audit report for the year ended
31 March 2018.
